What insight lies in historical returns?

Don't have a crystal ball? Neither do we. But looking at past market trends might lend some insight into what could happen in the future-just keep in mind that past performance is no indication of future results.

The charts on the following pages show the number of times gains and losses were observed on a 1-year, 3-year and 6-year rolling monthly basis for the periods shown on five diverse indices: S&P 500, Russell 2000, MSCI EAFE, MSCI Emerging Markets and MSCI KLD 400 Social.
